City Clerk informed the council the city received an anonymous phone call regarding the difficulty driving through town and accessing Hwy 15 from Hazel Ave due to poor parking at 11 Hazel Ave E.

The Council would like public parking signs put on Main Street to direct traffic to the parking lot.

The auditors will need to meet with one of the council members later this week. Council member Krippner said he will be available.

Council member Eric Loewen is going to contact MNDOT regarding notifying the City for road work.

The Council discussed the Magnus Johnson/Linden Ave project and the fact that the work is still not completed.
